

**CITY OF ALTAMONTE SPRINGS, FLORIDA**  
**EMERGENCY EXECUTIVE ORDER NO. 2022-02-E1**  
**IMPOSING VEHICULAR SPEED RESTRICTIONS**

**WHEREAS**, on September 29, 2022, Executive Order 2022-02 was executed, imposing vehicular speed restrictions on various city rights-of-way and streets due to the serious flooding caused by Hurricane Ian; and

**WHEREAS**, pursuant to Chapter 252, *Florida Statutes*, constitutional home rule powers, and Chapter 16, *Altamonte Springs Code of Ordinances*, the City of Altamonte Springs has adopted the Altamonte Springs Emergency Management Plan; and

**WHEREAS**, on September 26, 2022, a Local State of Emergency was declared under the provisions of Chapter 16, *Altamonte Springs Code of Ordinances*, due to the serious threat to life and property within the City arising from and related to Hurricane Ian; and

**WHEREAS**, Executive Order 2022-01-E1, dated October 3, 2022, extended the declared Local State of Emergency in the City of Altamonte Springs; and

**WHEREAS**, Sections 252.38(2) and 252.38(3)(a)(5), *Florida Statutes*, grants municipalities the authority to take whatever prudent action is necessary to ensure the health, safety and welfare of the community during a state of local emergency; and

**WHEREAS**, Chapter 16, *Altamonte Springs Code of Ordinances*, grants the City Manager, or designee, the authority to impose by Executive Order during a declared Local State of Emergency vehicular speed limits upon all or a portion of the streets and rights-of-ways of the City of Altamonte Springs, to limit impact to property from vehicular travel through flooded areas, and to protect public safety.

**NOW, THEREFORE, BY THE AUTHORITY VESTED IN ME AS THE CITY MANAGER OF ALTAMONTE SPRINGS, FLORIDA, IT IS HEREBY ORDERED THAT, IN ORDER TO PROTECT THE HEALTH, SAFETY AND WELFARE OF THE CITIZENS OF THE CITY OF ALTAMONTE SPRINGS, THE FOLLOWING EMERGENCY REGULATIONS ARE NECESSARY:**

**Section 1. Extension to Order Imposing Vehicular Speed Restrictions.** Vehicular travel speed limits in the following rights-of-ways and streets shall be restricted to speeds of five (5) mph, effective as of the date of this Executive Order:

Darwin Drive  
Diane Drive  
Lake Orienta Drive  
Lemonwood Court  
Little Wekiva Road  
Magnolia Drive  
Peachwood Drive

**Section 2. Duration of Restrictions.** These restrictions will remain in effect within the flooded areas of Altamonte Springs, Florida, or within the areas of the City as may be determined by the City Manager. These restrictions will remain in effect from the date of this Order for a period of seven (7) days and may be extended in seven (7) day increments by further Executive Order.
